

The network cameras WV-SFV481/WV-SFN480 are designed to be operated using a PC on a network (10BASE-T/100BASE-TX).

By connecting the camera to a network (LAN) or the Internet, images and audio from the camera can be monitored on a PC via a network.

Note:

It is necessary to configure the network settings of the PC and its network environment to monitor images from the camera on the PC. It is also necessary to install a web browser on the PC.

About notations

The following notations are used when describing the functions limited for specified models. The functions without the notations are supported by all models.

<Outdoor Vandal resistant & waterproof model>

SFV481: The functions with this notation are available when using the model WV-SFV481.

<Indoor model>

SFN480: The functions with this notation are available when using the model WV-SFN480.

Main functions

Twice the resolution and sensitivity of conventional sensors*1 thanks to a high-sensitivity 12M MOS sensor

The camera allows 9 megapixel (1:1), high-resolution fisheye image output, and with the BW function, high-sensitivity recording is also possible at night.

The camera also allows 9 megapixel H.264 15 fps streaming and 4 megapixel H.264 30 fps streaming output.

360° monitoring with a wide variety of transmission modes

With the high-performance fisheye lens, clear 360° image capture of the surroundings is possible with a single camera. The 360° camera includes a wide variety of image capture modes that perform distortion correction: Wall Panorama, Double Panorama, Quad PTZ, Single PTZ, and Quad streams (H.264). It also supports modes that can transmit fisheye images and corrected images at the same time.

SD memory card*2 slot equipped

It is possible to save H.264 videos and JPEG images on the SD memory card manually at an alarm occurrence, during the period of the schedule, or on a web browser. (Download is possible.) It is also possible to save JPEG images at a network failure occurrence.

SFV481

The camera conforms to the IP66*3 and Type 4X (UL50)*4, is compliant with NEMA 4X*5 ratings, and provides high dust resistance and waterproof performance.

Waterproofing treatment is not required for the camera body (waterproofing treatment is required for cable connections).

- *3 IP66 rating: The applicable product has "Dust tight (6)" protection against foreign solids and has "Powerful water jets (6)" protection against water (IEC60529).
- *4 UL50 is a waterproofing standard regulated by UL, and Type 4X indicates the waterproofing class.

It is now possible for the camera to take in 9 megapixel high-resolution fisheye images, and correct the parts of live images and played images that you wish to view into Single PTZ/Quad PTZ images.

Install with Panasonic network microphone for 360° image and audio recording

By installing the camera with a network microphone (WV-SMR10), you can simultaneously record audio and images from any direction.

This product is designed to be used indoors. This product is not operable outdoors.

Make sure that the product does not become wet.

Keep this camera away from water and moisture.

This product has no power switch.

When turning off the power, disconnect the power supply from the 12 V DC power supply or the PoE device.

Before turning off the camera power switch, make sure that the SD MOUNT indicator (green) is turned off. If you turn off the camera power switch while the SD MOUNT indicator (green) is lit or flashing, the recorded data may be corrupted or damaged.

Direct current symbol (

The product is suitable for direct current only.

Handle this product with care.

Do not drop this product, nor apply shock or vibration to the product. Failure to observe this may cause trouble.



If a strong shock or vibration is applied to the enclosure, it may cause damage or allow water to enter this product.



If a strong shock or vibration is applied to the lens, it may cause damage.

About the battery

A battery is installed inside the camera. Do not leave the battery exposed in environments of excessive heat as a result of sunlight or fire.

Do not touch the dome cover SFV481 or lens SFN480 with your bare hands.

Dirty surfaces cause deterioration of picture quality.

About the PC monitor

When displaying the same image on the monitor for a long time, the monitor may be damaged. It is recommended to use a screen-saver.

When an error is detected, this product will restart automatically.

This product will be inoperable for around 2 minutes after the restart just as when the power is turned on.

About the automatic status detection function

When this product malfunctions due to exogenous noise, etc. for 30 seconds or more, the product will automatically reset and will return to normal state. When the product is reset, initialization will be carried out as when the power of the product is turned on. When the product repeatedly resets, exogenous noise level around the product may be high and that may cause malfunction. Contact your dealer for instructions.

Transmission interval

Image transmission interval may become slow depending on the network environment, PC performance, shooting subject, access number, etc.

Periodically images on the screen appear to be distorted

When the camera is installed in a location where it is subject to small vibrations (for example, when it is installed near devices that vibrate), images may appear distorted and stretched lengthways. This phenomenon is a characteristic of image pickup devices that use MOS sensors and is caused by the relationship between the periodic movements of the camera and the timing that the image sensor reads images. This is not a problem with the camera. To reduce the possibility of this phenomenon occurring, install the camera in a secure location.

About SD memory card

- To remove the SD memory card, hold down the SD ON/OFF button for about 2 seconds. When the SD MOUNT indicator goes out, you can remove the SD memory card.
- When using an SD memory card, format it using this product. Recorded data on the SD memory card will be deleted when formatted. If an unformatted SD memory card or an SD memory card formatted with other devices is used, this product may not work properly or performance deterioration may be caused. Refer to the Operating Instructions on the provided CD-ROM for how to format an SD memory card.
- When some SD memory cards are used with this product, the product may not work properly or performance deterioration may be caused. Use the SD memory cards recommended in page 26.
- For SD memory cards that support Speed Class 10, use cards that support UHS-I (Ultra High Speed-I).

About the dehumidifying device

- This product has dehumidifying device to keep the inside at low moisture level, preventing condensation and quickly dissipating dew if produced.
- Dew may be produced depending on the conditions of temperature, humidity, winds, and rain, and it may take time to dehumidify.

 The dehumidifier element is mounted inside the sub cover. In order to maintain normal operation of the dehumidifier function, do not caulk (fill the clearance with sealants or other materials) the clearance between the enclosure and the ceiling or wall.





What to do if "WARMING UP-PLEASE WAIT" appears on the display.

This message indicates that the temperature inside the camera has become extremely low. In such a case, wait until the internal temperature of the camera rises (for around 2 hours or more in low temperatures below -20 °C {-4 °F}), and turn on the power again.

About the MOS image sensor

- When continuously shooting a bright light source such as a spotlight, the color filter of the MOS image sensor may become deteriorated and this may cause discoloration. Even when changing the fixed shooting direction after continuously shooting a spotlight for a certain period, the discoloration may remain.
- When shooting fast-moving subjects or objects crossing the shooting area may look to be bending askew.

Cleaning this product body

Be sure to turn off the power before cleaning. Failure to observe this may cause injury. Do not use benzine, thinner, alcohol, or any other types of solvents or detergents. Otherwise, it may cause discoloration. When using a chemical cloth for cleaning, read the caution provided with the chemical cloth product.



Cleaning the dome cover

In case of adhesion any dirt or other unwanted substances, please wipe it with a lens cleaning paper and so on.

Cleaning the lens

Use a lens cleaning paper (used to clean camera lenses or lenses of spectacles). When using solvent, use an alcohols solvent and do not use a thinner or a glass cleaner.




