Facial Recognition Server Software WV-ASF950 (hereinafter this software) is the face recognition software for surveillance systems working on Microsoft Windows operating system. The computer (hereinafter PC) on which this software is installed receives the face image captured by the particular Panasonic network cameras (hereinafter cameras), and stores the facial image and facial feature information in the database. You can detect a specific person by alarm notification which it is send when he/she is verified against a registered person in the database, or by certain operation from client terminal connected with this PC.

This software includes four cameras license. To increase camera number as five or more, it is necessary to register the license of the Additional Camera Kit (option).

Installation

1. Insert the provided DVD-ROM into the DVD-ROM drive on the PC.
2. Double-click "ASF950Launcher.exe" under the root directory. If Microsoft .NET Framework 4.6.x has not been installed on the PC, it will be installed automatically. Wait until the installation is complete. Then, the installer of Face Recognition Server Software will be launched.
 - Install the software by following the instructions displayed on the monitor.
The executable files, etc. will be copied on the PC.
3. Reboot the PC.
 - When completing steps 1 - 2, reboot the PC to complete the installation.

Uninstallation

- When a message window is displayed in the process of the uninstallation to ask you to update a file that are used by the system, click the [Cancel] button on the displayed window to cancel the uninstallation. After stopping the this software's services, retry the uninstallation.

1. Select "Settings" - "Apps" - "Apps & features" from the Start menu.
2. Select "WV-ASF950 Series" from the presently installed programs and click the [Uninstall] button.
 - The uninstall program will be launched and the wizard will be displayed.
3. Uninstall the software by following the instructions displayed on the monitor.
4. Select "Postgre SQL 10.x" from the presently installed programs and click the [Uninstall] button.
